# **Decisions of the meeting**

It was decided to approve the bylaws by September 2005, meanwhile, the members can give their suggestions through feedback form in the website of MEPA. Bylaws will also be inserted in the website for the future reference of members.

It was decided to concentrate on print media publishers' in Middle-East and later electronic media publishers will be included in the Association.

It was also suggested by the participants to set a brain storming session and everybody has to contribute their ideas.

The difference between founding members and steering committee members was also clarified. Those who publish in the specified region and those who offer AED 50,000/-

can become founding members. In the case of steering committee, only founding member of the Association and those who can actively participate in the committee can become members of steering committee.

Some participants expressed that the market of the UAE is very complex and multiethnic, so MEPA has to formulate rules to cope up with the situations. . It was suggested to classify the publishers in three levels i.e. Higher / Middle / Lower and charge the membership fee according to their status.

### **Conclusion:**

Dr Azzam, Chairman of MEPA concluded the session by worth mentioning that Dr. Jacob will work on the issue of formulation of by-laws of MEPA and he will wait for the feedback of the participants, if any.
